1. SUBJECT of CONTRACT

and hereinafter called "Contractor"

The Contractor participates in the implementation of the project "Umsetzung des Konzepts über ein effektives Management des nördlichen Teils des Slovenský Raj Nationalparks" (Implementation of a Concept for an Effective Management in the Northern Part of the Slovenský Raj National Park)", co-funded by the German Federal Environmental Foundation (DBU).

Therefor the Contractor shall complete his tasks fully in line as laid down in the project application to DBU from April 9, 2020 (in German language) in the attachment no. 01 of this contract. This, like all other documents (budget etc.) in the attachment is an integral part of the present contract.

Overall 9 defined measures have to be worked on in this project:

- 1. Improving of technical aids in the gorges
- 2. Improving of the NP information centre at Podlesok
- 3. Information system of the Suchá Belá gorge
- 4. Automatic counters of hikers in selected gorges
- Information system about accessibility of gorges
- 6. Monitoring system of water level and gorge closing
- 7. Set of printed materials
- 8. Ecological toilet in the national park
- 9. Co-management

As laid down in the approval (attachment no. 02.) from September 30, 2020, the DBU will finance 50% of all expenditures related to activities of OOCR in the frame of this project. OOCR itself has to raise the other 50% by own resources.

2. PROJECT MANAGEMENT AND DURATION OF PROJECT

The Contractor is the coordinating institution and responsible for the local management in the project region. The Contractor shall cooperate with all partners in this project. Project partner – beneath ETE – is Štátna ochrana prírody SR (ŠOP SR) / Národný park Slovenský raj.

fully responsible for its part in the implementation of this project and carry out its


